stated in the posted notice. The Notice and Agenda for the meeting are attached hereto. All proceedings of the Board of Governors, except as may be hereinafter noted, were taken while the convened meeting was open to the attendance of the public.

INTERVIEWS OF FINALIST CANDIDATES FOR DISTRICT THREE SEAT VACANCY

The Board developed and reviewed a process to conduct the interviews of the finalist candidates for the vacant District Three seat on the Board of Governors.

The Board then interviewed the finalist candidates for the vacant District Three seat on the Board of Governors of the Southeast Community College Area in the following order: Jason Smith, Kevin Nelson, Dr. Colette Yellow Robe, and Dr. James Sherwood.

APPOINTMENT TO FILL VACANT AT-LARGE SEAT

All of the following were held in open session:

- Each of the candidates was interviewed and asked the same questions by the Board of Governors.
- Each candidate responded to each guestion.

Upon completion of the interviews, Ms. Seim moved that all four (4) finalist candidates be nominated for consideration for the vacant District Three seat. Seconded by Mr. Byers.

Final ballot voting results consisted of the following: Weissinger, Uhrmacher, Yates, and Garver for Yellow Robe; Byers, Stenberg, Seim, Hammons, and Boellstorff for Sherwood.

Mr. Byers moved that the Board of Governors of Southeast Community College, pursuant to Neb. Rev. Stat. §32-570 should and does hereby appoint Dr. James Sherwood, a qualified registered voter of the Southeast Community College Area, to fill the vacancy in the District Three seat on the Board of Governors; said appointment is effective upon the passage of this motion and administration of the oath of office, and shall continue for the remainder of the unexpired term of the District Three vacant seat. Seconded by Mr. Stenberg.

Chairperson Boellstorff asked for discussion. Discussion followed.

Chairperson Boellstorff reread the motion and a vote was taken.
