Chairperson Stenberg welcomed everyone to the meeting.

PUBLIC MEETING LAW COMPLIANCE STATEMENT

Chairperson Stenberg stated the public meeting notice had been published in the Lincoln Journal Star on Tuesday, March 21, 2023, as well as posted on the bulletin board in the Area Office and on the website. He indicated that the meeting is conducted according to the principles of the revised *Robert's Rules of Order*.

Chairperson Stenberg indicated that supplementary materials were available for the public, along with a copy of the Open Meetings Law.

INTERVIEWS OF FINALIST CANDIDATES FOR DISTRICT ONE SEAT VACANCY

Chairperson Stenberg stated the order of interviews was selected randomly as witnessed by Dr. Sherwood and Dr. McCormick. He stated the following process would be used to conduct the interviews of the finalist candidates for the vacant District One seat on the Board of Governors:

- Each candidate will be asked the same six questions and allowed three minutes per question to answer.
- Questions will be read to candidates. Candidates will also have a hard copy of the questions in front of them during the interview.
- Candidates will not be asked follow up or other questions.

- Each candidate will be allowed two minutes to give a closing statement.
- Time will be kept and candidates will be signaled for one-minute remaining and time expired by Blanca Padilla, Executive Assistant.

The Board interviewed the finalist candidates for the vacant District One seat on the Board of Governors of the Southeast Community College Area in the following order:

The Board followed the process set forth above in conducting the interviews of the finalist candidates for the vacant District One seat on the Board of Governors.

APPOINTMENT TO FILL VACANT DISTRICT ONE SEAT

All of the following were held in open session:

- Each of the candidates were interviewed and asked the same questions by the Board of Governors.
- Each candidate responded to each question.

Upon completion of the interviews, Chairperson Stenberg stated nominations would be taken from the floor for finalist candidates to be considered for the vacant District One seat.

Chairperson Stenberg asked for nominations.

Dr. McCormick nominated Vicki Haskell.

Mr. Byers nominated Jack Roegner.

Ms. Seim nominated Monte Murkle.

Chairperson Stenberg asked for discussion.

Mr. Uhrmacher discussed Ms. Vicki Haskell's responses to the interview questions.

Dr. Sherwood and Mr. Byers mentioned their view on all applicants.

Ms. Boellstorff, Dr. McCormick, and Ms. Herrington elaborated on Ms. Vicki Haskell's responses to the interview questions.

The Board of Governors considered the qualifications and responses in the interview process of each candidate. Votes were cast by roll call vote and tallied by Blanca Padilla.

A majority vote was met for Vicki Haskell.

Chairman Stenberg announced that, having received a majority of the votes cast, Vicki Haskell was elected by the Board to fill the vacancy in District 1 for the unexpired term.

Mr. Uhrmacher moved pursuant to Nebraska Revised Statute Section 85-1514 to appoint Vicki Haskell, a qualified registered voter in the Southeast Community College Area, to fill the vacancy in the District One seat on the Board of Governors. Said appointment shall continue for the remainder of the unexpired term in the District One vacant seat. Seconded by Ms. Herrington.

Chairman Stenberg then stated that Ms. Haskell had already been elected to fill the vacancy because she had received a majority of the votes cast and that further voting was unnecessary. Chairman Stenberg asked Mr. Uhrmacher to consider withdrawing the pending motion which he did. Accordingly, no action was taken on the motion.

Chairman Stenberg reiterated that Vicki Haskell had been elected to fill the vacancy in District 1 for the unexpired term and that she would be so notified.

The above Motion, having been consented to and approved by a majority of the members of the Board of Governors of this College, was declared as passed and adopted by the presiding officer of the Board of Governors at a duly held and lawfully convened meeting in full compliance with the Nebraska Open Meetings Law.

ADJOURNMENT

Chairperson Stenberg adjourned the meeting at 7:15 p.m.
