

Chairperson Neal Stenberg called the work session of the Southeast Community College Board of Governors to order at 12:30 p.m. on Tuesday, February 20, 2024, at the Southeast Community College – Lincoln Campus, 8800 "O" Street, Lincoln, NE.

#### PUBLIC MEETING LAW COMPLIANCE STATEMENT

Chairperson Stenberg stated the public meeting notice had been published in the Lincoln Journal Star on Monday, February 12, 2024, as well as posted on a bulletin board in the Lincoln Campus Administrative Suite and on the website. He indicated that the meeting is conducted according to the principles of the revised **Robert's Rules of Order**.

Chairperson Stenberg indicated that supplementary materials were available for the public, along with a copy of the Open Meetings Law.

Courtney Wittstruck, NCCA Executive Director, reported on:

Ms. Hartman asked how does LB1388 Promise Act impact Pell eligible students? Ms. Wittstruck stated that it is last money in and Pell eligible students may not get anything, since those students received 100% from Pell Grants.

#### **Enrollment and Funding Model Implications**

Dr. Illich, President, presented on how enrollment relates to the new funding model. The new funding model bases the funding partially on what's called reimbursable education units for the entire year and SCC had to start with the fall of 2023. Dr. Illich also reported on:

- Fall 2023, SCC went up 3.9% compared to the fall of 2022, head count
- Milford up 11% for fall 2023, Lincoln Campus 2.2%, and Beatrice Campus 5.2%
- 12% increase in Spring 2024

- 12% increase in REUs
- 69% 2023 Fall to 2024 Spring Retention Rate compared to 66% in 2022-23
- Estimated 7% to 9% increase in REU for 2023-24
- Impact on new CCFF model
  - $\circ~$  3.5% increase in the CCFF funding means SCC would get up to 9%
- Approximately 60% increase in REUs is related to career/technical programs
  - Arts and Science enrollment increased by 14.5%
  - 45% of arts and science course enrollment is associated with career and technical students
- Milford 20% increase
- Lincoln and Beatrice 8% increase
- Amended CCFF Language in LB1412

Ms. Seim stated how great it was to see the increase in students.

Dr. Sherwood asked how dual enrollment and the career academy were figured into the growth? Dr. Illich stated it was associated with a percentage but it was not the bulk of the growth.

Mr. Uhrmacher stated he was impressed with the increase in IT technology and Welding with those facilities still being under construction.

Dr. Sherwood asked if tuition is mentioned during discussions? Dr. Illich stated yes tuition is mentioned in discussions as well. Senators have asked what is the cost of tuition.

Kat Kreikemeier, Administrative Director Admissions Student Affairs reported on:

Ms. Boellstorff asked what impact covid had on high school students coming in as far as college readiness? Ms. Kreikemeier stated from her experience and solely when doing placement testing that she had not seen a significant impact on their scores.

Dr McCormick asked if students that were not admitted been notified of the changes? Ms. Kreikemeier stated that yes, those students were all notified and admitted.

- Sick Leave becoming a liability to the college

Chairperson Stenberg asked how would sick leave be accumulated? Ms. Gustafsson stated it is the number of hours that they had in their bank of that particular balance sheet date and it is values at their current pay rate and reevaluated every year.

Ms. Hartman asked when does the sick leave take affect? Ms. Gustafsson stated it would take affect the next fiscal year.

The completed 2022-2023 FTE/REU audit reports were presented by Robin Moore, Administrative Director of Institutional Effectiveness & Research and the representing auditor from Dana F. #### Mueller Robak Legislative Lobbyist update

Tim Hruza and Matt Shafer, Partner of Mueller Robak. Mr. Hruza mentioned that they are four attorneys in the office, two staff members, and are a full-time government relation lobbying firm. Mr. Hruza reported on:

- Represents around four dozen clients
- Flag and review legislative bills
  - o 597 bills introduced in 2024
  - Two-year biennial total over 1400 bills that the legislature was operating
  - 25 to 30 bills that may have some sort of impact or effect on SCC
- Advocating for SCC
  - Talk to Senators on a regular basis
  - o Attend hearings
- Building relationships with Senators and Governor's teams

Dr. McCormick asked are Senators talking about changing the formula? Mr. Hruza stated he had not heard of any changes at the moment.

Chairperson Stenberg asked if their seemed to be any resentment from last year? Mr. Hruza stated no, they had not heard or seen any resentment towards Southeast Community Colleges.
