Annual Billing Adjustments at Daily Rate for All Families

- Week of New Year's Day and teacher/staff professional development day, billed 3 days
- · Week of Martin Luther King, Jr Day, billed 4 days
- · Week of Memorial Day, billed 4 days
- · Week of July 4th, billed 4 days
- Week Lincoln Public Schools start, billed 4 days for teacher/staff professional development and work day
- Week of Labor Day, billed 4 days
- Week of Thanksgiving, billed 2 days
- Week of SCC's Winter break, billed ZERO tuition

Inclement weather days, when SCC is closed, accounts will be credited the prorated weekly tuition based on Center closure.

Registration and Enrollment Fee

- A one-time, refundable Registration Fee of \$135 is due to secure the initial placement, in the center (the Registration Fee for additional children, in the same family, is \$75). This fee is refundable, less any outstanding bill, with a two week notice upon terminating care.
- Annually thereafter on July 1st an Enrollment Fee of \$145, per family, is billed.
