**PUBLIC MEETING LAW COMPLIANCE STATEMENT**

Chairperson Uhrmacher stated the public meeting notice had been published in the Lincoln Journal Star on Tuesday, November 28, 2025, as well as posted on the bulletin board in the Area Office and on the website. **INTERVIEWS OF FINALIST CANDIDATES FOR DISTRICT Four SEAT VACANCY**

Chairperson Uhrmacher stated the order of interviews was selected randomly as witnessed by Mr. Gunther, Dr. Sherwood and Ms. Haskell. He stated the following process would be used to conduct the interviews of the finalist candidates for the vacant District Four seat on the Board of Governors:

- Each candidate will be asked the same six questions and allowed five minutes per question to answer.
- Questions will be read to candidates. Candidates will also have a hard copy of the questions in front of them during the interview.
- Candidates will not be asked follow up or other questions.
- Each candidate will be allowed three minutes to give a closing statement.
- Time will be kept and candidates will be signaled for one-minute remaining and time expired by Blanca Padilla, Executive Assistant.

The Board interviewed the finalist candidates for the vacant District Four seat on the Board of Governors of the Southeast Community College Area in the following order:

Discussion was had regarding both candidates.

The Board of Governors considered the qualifications and responses in the interview process of each candidate. Votes were cast by roll call vote and tallied by Blanca Padilla.
